Your South Jersey Gas Bill FOR RESIDENTIAL CUSTOMERS

Understanding how your natural gas bill is calculated can be confusing. Our goal is to help you understand the charges that make up your bill and reassure you that the cost of natural gas is less expensive than other energy sources. While some charges cover the cost of the natural gas itself, others are either necessary so that we can maintain a safe and reliable delivery system for you, or are mandated by the State of New Jersey. All rate changes are approved by the New Jersey Board of Public Utilities before they are implemented.



Two primary parts that make up your SJG natural gas bill:

Keep in mind the basic billing unit for natural gas usage is a therm. The examples below may not reflect the rates shown on your bill. All rates shown on your bill are inclusive of New Jersey Sales and Use taxes.

1 Gas Charges: BGSS (Basic Gas Supply Service)

This is the actual cost of the natural gas you use in your home for heat, water heating, cooking, drying clothes, enjoying the ambiance of a gas fireplace, a generator for back up if there is an electric outage, and more. Every home is different. We work hard to purchase natural gas at the most competitive market price for you. **SJG does not earn a profit on the cost of natural gas. You pay what we pay.**

GAS CHARGES (BGSS)

Total Gas Charges are calculated by multiplying the number of therms you use by the cost per therm. Fluctuations in your energy usage can affect this line item on your bill.

2 Usage Costs: Two charges in this section of your bill

Customer Charge

This charge includes administrative costs (metering, billing, and recordkeeping) and is incurred even if no gas is used. It is currently a monthly charge of \$10.50 per the SJG Tariff and may be prorated based on the number of days in a billing period. The days in a billing period are included on your bill.

Delivery Charge

The term Delivery Charge can be confusing because in everyday terms, it suggests a fee for delivering a product or service on a one-time basis. However, for SJG, the Delivery Charge covers the cost to deliver gas to your home **24 hours a day, 7 days a week, 365 days a year** as well as the cost for certain State mandated programs. Specifically, the Delivery Charge includes:

- The cost of building and maintaining a safe and reliable system of infrastructure to transport natural gas.
- The cost of maintaining and enhancing customer service operations, information technology, cybersecurity protections, and more.
- Costs related to State mandated programs such as supporting energy efficiency programs to help customers use less energy or providing financial assistance programs to seniors and income-eligible customers.

Importantly, the Delivery Charge is based on your usage during a billing period. In general, the more natural gas you use, the higher your Delivery Charge will be. This is why it is important to manage your energy usage efficiently.

*As noted in the Customer Charge section above, the \$10.50 monthly charge is the SJG Tariff rate and may be prorated depending on the number of days in the billing period.
