Sweepstakes Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS PROMOTION. A purchase will not increase your chance of winning.

- **1. PROMOTIONAL PERIOD.** This South Jersey Gas Sweepstakes (the "<u>Promotion"</u>) commences on **October 1, 2023**, at 12:01 a.m. and ends on **November 15, 2023**, at 11:59 p.m.(<u>the "Promotional Period"</u>).
- 2. WHO IS ELIGIBLE. The Promotion is open to all legal residents of the United States who reside within the South Jersey Gas service territory. The employees, agents, directors, officers, and contractors of the following entities are not eligible to participate in this Promotion (the following entities being the "Promotional Entities"): (a) South Jersey Gas Company; (b) the advertising, fulfillment, judging, and promotional agencies involved in the development and administration of this Promotion; and (c) the parents, subsidiaries, and affiliated companies and distributors of the foregoing entities. The immediate family members (spouse, parent, child, sibling, and their respective spouses and children, regardless of where they reside) and household members (whether or not related) of the employees, agents, directors, officers, and contractors of the Promotional Entities are not eligible to participate in this Promotion. This Promotion is void outside the United States and where prohibited by law. By entering the Promotion, you agree to be bound by the terms of these Official Rules.
- 3. **HOW TO ENTER.** There are two ways to enter.
 - a. **Method #1**: **Entering a Gas Contract with South Jersey Gas:** To enter via the Gas Contract method, you are required to enter into a Residential Natural Gas Service Contract with South Jersey Gas Company. The date and time of entry will be the date and time that the Sponsor receives the signed Gas Contract. The Contract must be complete and received by the end of the Promotional Period.
 - b. **Method #2: Alternate Method of Entry:** To enter without entering into a Gas Contract with South Jersey Gas Company, on a 3" x 5" card, handprint your name, mailing address, city, state, zip code, telephone number (including area code), email address, and date of birth, insert 3" x 5" card in an envelope, affix proper postage to envelope and mail to: Attn: South Jersey Gas Marketing Department 1 South Jersey Place, Atlantic City, NJ 08401. Entries must be postmarked and received by end of the Promotion Period in order to be eligible for the prize drawing. Incomplete, illegible, inaccurate or postage due entries will be automatically disqualified. All alternate entries become the property of Sponsor and will not be returned.
 - c. Limit one entry per person, regardless of the manner of entry. Entries received outside of the Promotional Period will not constitute an entry into the Promotion. Each entry must be submitted in the name of an individual person. Entering the Promotion does not mean the entrant has won a prize. Entrants may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If an entrant uses fraudulent methods or otherwise attempts to circumvent the rules, the submission may be removed from eligibility at the sole discretion of the Sponsor. The Sponsor is not responsible for misdirected, unintelligible, incomplete, lost, or late entries, or for technical, hardware, or software failures, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmissions or other errors or problems of any kind associated with submitting an entry.
- **4. PRIZE DRAWING.** A winner will be selected in a random drawing on or about November 20, 2023 from among all eligible entries received during the Promotion Period.

5. PRIZE WINNER NOTIFICATION & REQUIREMENTS. The prize will be delivered to the winner at the address supplied at the time of entry. In the event the prize is returned, the address is insufficient, or undeliverable for any reason, the prize winner will be disqualified, and the Sponsor reserves the right, but does not have the obligation, to award the prize to an alternate entrant who will also be selected randomly, even if the disqualified potential winner's name was publicly announced.

The receipt by winner of the prize offered in this Promotion is conditioned upon compliance with any and all federal and state laws and regulations. - **7. PRIZE TERMS.** All taxes are the sole responsibility of the winner. The odds of winning a prize are one out of the total number of eligible entries received. The Sponsor will pay for shipping of the prize to the prize winner within the United States or will otherwise arrange for the prize winner to pick up the prize.

DISQUALIFICATION.** Persons who tamper with or abuse any aspect of the Promotion or website, who are in violation of these Official Rules, or who act in an unsportsmanlike or disruptive manner (as solely determined by Sponsor) will be disqualified and all associated entries will be void. Sponsor reserves the right at its sole discretion to suspend, modify, or terminate the Promotion for any reason, including, but not limited to, should any portion of the Promotion be, in Sponsor's sole opinion, compromised by computer viruses, non-authorized human intervention, or other causes which, in Sponsor's sole opinion, corrupt or impair the administration, security, or fairness of the Promotion. If so terminated, Sponsor may (but has no obligation to) randomly select the winner from among all eligible, non-suspect entries received prior to termination, or take other action the Sponsor deems fair and reasonable. Automated entries are prohibited and any use of automated devices will cause disqualification.
- **10. RELEASE & INDEMNIFICATION.** By entering the Promotion, each entrant agrees for himor herself and for his or her heirs, executors, and administrators (a) to release, defend, indemnify, and hold harmless the Promotional Entities and their respective officers, directors, employees, agents, affiliates, and parent corporations (collectively, the "Released Parties") from any and all costs, injuries, losses, or damages of any kind due in whole <u>or in part, directly</u> or indirectly, to participation in the Promotion or any Promotion-related activity, or from entrant's

- **13. GOVERNING LAW.** This Promotion is governed by the laws of the State of New Jersey, without respect to conflict of law doctrines.
- **14. GENERAL TERMS.** If any term or condition of these Official Rules is invalid or unenforceable, then the term or condition may be modified or amended by the Sponsor to render it enforceable to the maximum extent permitted; if modification or amendment is not practicable, then the term or condition shall be severed from these Official Rules with no effect upon the remaining provisions. These Official Rules state the entire agreement between the Sponsor and the entrant. These Official Rules do not confer any rights or remedies upon any person other than the Promotional Entities and the entrants. The Promotional Entities will not be considered in default under these Official Rules to the extent that their performance is delayed or prevented by events outside such entities reasonable control. The failure of Sponsor to insist upon the performance of any provision hereof or to exercise any right or privilege granted hereby will not be construed to be a waiver of such provision, right, or privilege. These

Official Rules shall be binding on the entrant and his or her heirs, executors, administrators, and successors and permitted assigns.
